COURSE DESCRIPTIONS FOR 2017 SPRING CONFERENCE

Auditing II (3 hours): Learn about key issues from the filed including compliance, risk assessments, sampling and coordinating the review of POP III students. Techniques for working with district staff in the field and handling teacher and staff interviews will be included. *Presenters – Brenda Walther, Genesee ISD and Melanie Wood, Genesee ISD*

CEPI Update (1 hour): This must attend session will cover what's new at CEPI and what you need to know about current and upcoming collections. Included will be information on collection changes for the 2017-2018 school year. *Presenters – Trina Anderson and Tosha Johnson and Doris Mann, CEPI*

Data Breach Response Training (1.5 hours): An interactive role-based simulation of a K-12 district-level data breach, focusing on the processes, procedures, and skills needed to respond. This can be customized to other levels/organizations. Review of the current plan for data breach response. Revised response plan, incorporating lessons learned and best practices. *Presenter – Ross Lemke, Privacy Technical Assistance Center, US Department of Education*

Data Security Best Practices/Training (1.5 hours): Training on current data security best practices for education data systems, including user privacy and security awareness, privacy and security program development/implementation, threat modeling, and attacker methodology. Increased awareness of privacy and data security threats. Reduces risk of security incidents and improved ability to respond to incidents. *Presenter – Ross Lemke, Privacy Technical Assistance Center, US Department of Education*

Demystifying the GAD (1.5 hours): The interaction between auditor and the data specialist/pupil accountant cannot be underestimated when it comes to Graduation and Dropout (GAD) process. Join MPAAA Executive Director Rob Dickinson to discuss the requirements and time lines for reporting and correcting the students that make up your graduation rates. A review of regulations and requirements will be discussed, and best practices on finding every possible student to minimize losses will be shared. *Presenter – Rob Dickinson, Executive Director MPAAA*

FERPA 101 Training (1.5 hours): Review and discussion of real-life scenarios on FERPA and its applicability to your institution. Participants have an opportunity for interactive Questions and Answers. Improved understanding of FERPA and the context for the law. Reduced misconceptions/misunderstandings about FERPA. *Presenter – Ross Lemke, Privacy Technical Assistance Center, US Department of Education*

Green Auditing (1.5 hours): For several years now, there has been a push within the auditing community to complete Pupil Accounting audits with much less paper being used. Attendees will be given advice and tips on how a School District can comply with a green audit, and still maintain data quality and integrity. *Presenters – Barbette Lane*

Green Auditing MPAAA Rollout (1.5 hours): Come and hear the exciting news about the Association's efforts to make Green auditing available to any ISD in Michigan AT NO COST TO THE ISD. You will learn how this system works, what benefits it may have for your ISD, and the rollout schedule. *Presenters – Barbette Lane, Wexford-Missaukee ISD and Rob Dickinson, MPAAA Executive Director*

Homeless/Foster Care (1.5 hours): Learn the latest update on services and opportunities available to homeless and foster care students in Michigan. *Presenter – Pam Kies-Lowe, MDE*

Intermediate Excel (1.5 hours): Building on the Beginner's Excel session given at previous conferences, this session will expand the attendee's knowledge of Excel, looking at data lookup functions, and what/if logic as it applies to Excel spreadsheets. *Presenter – Janell Craig, Oakland Schools*

Introduction to MS Access (1.5 hours): Please bring a laptop with Microsoft Access installed to this hands-on session as you will be going over the basics of Access and how you can use it to analyze data. A sample database will be distributed and attendees will work through exercises to understand the basics of tables, queries, and reports. *Presenter – Rob Dickinson, MPAAA Executive Director*

Introduction to Pupil Accounting I (3 hours): Pupil Accounting I introduces staff new to pupil accounting to the Pupil Accounting Manual (PAM) and requirements related to count days. This presentation includes a review of timelines, enrollment requirements and information about the three student populations as defined by the PAM. This session will fulfill the MSBO Introduction to Pupil Accounting I certification requirement for Pupil Accounting Specialists, Pupil Accounting Auditors, and Educational Data Specialists. (Certification track PAS/PAA/EDS). Presenters – Mary Beth Stein, Traverse City Area Schools and Holly Strong, Jackson ISD

Introduction to Pupil Auditing (3 hours): This introduction to pupil accounting auditing focuses on learning the basics of preparing for an audit, acronyms, quality control reviews and tips related to the audit narrative. Embedded in this session are tips on ways to connect and work with various officials with the Michigan Department of Education (MDE). This session will fulfill the MSBO Introduction to Pupil Auditing certification requirement for Pupil Accounting Specialists and Pupil Accounting Auditors. Legislative Update (1.5 hours): This session will provide an update on legislation that passed and/or pending this year that affects pupil accounting, auditing, and data submissions. Pupil Accounting Auditors in Action (3 hours): Learn from experts the critical information needed to create and manage pupil auditing functions that offers district staff with clear guidelines and appropriate support mechanisms. You will be exposed to an introduction to the legal issues facing Pupil Accounting, Pupil Auditing and State Reporting staff related to educational issues; enrollment issues, FERPA, student records, teacher certification, etc., as well as data quality and data collections. SRM – When, How Why to Use Them? (1.5 hours): This session will examine the details of SRM collections. Understand the importance of the 'As Of' date, and learn the various timelines during the year that SRM submissions can be used to correct and update the data in CEPI's student systems. *Presenters - MDE, CEPI, and LEA Staff*

State Agency Panel (Introduction to State Agency Resources (1 hour)): Receive an introduction to state agency personnel from CEPI and MDE (including Office of the Audits, Office of State Aid and School Finance, Office of Special Education, Office of Special Education, etc., who create and/or implement the business rules, administrative rules and other processes affecting district, ISD staff or contracted auditors. 5-0 in 2017/18 (1.5 hours): This session will provide attendees with an update to changes in the Pupil Accounting manual for 17/18 in regards to the various parts of the online learning rules (section 5-O in the manual).
